## Request for Bids/ Sealed Quotation for the Procurement of different Tools and Equipments

- 1. The REDD Implementation Centre has received financing from the World Bank and intends to apply parts of the proceed towards payments for three separate bids and one sealed quotation: 1) Procurement of Tree measuring equipment for emission reduction program districts such as Range finder, Clinometer, GPS, Dtape, L-tape etc. (Ref No. NP-REDD-271546-GO-RFB); 2) Procurement of tools and kits for forest fire control such as firefighting dress, tools, first-aid kit etc. Package-1 (Ref No. NP-REDD-271549-GO-RFB); 3) Procurement of Back pack pump equipment for forest fire control Package-2 (Ref No. NP-REDD-271550-GO-RFB); and 4) Sealed quotation for Procurement of Goods and equipment for strengthening of Dendrochronology lab (Advanced Micro-scope, Trephore Micro-core, etc.) (Ref No. NP-REDD-271567-GO-RFQ).

A complete set of Bidding Documents may be downloaded from the office website: www.redd.gov.np or PPMO's e-GP system i.e., www.bolpatra.gov.np/egp by eligible Bidders upon payment of a non-refundable fee of NRs. 3000.00 for bids and NRs 1000.00 for sealed quotation in Revenue Account No. 1000200010000, Office Code 329013503, Revenue Head 14229 at Rastriya Banijya Bank during office hours.
- 3. Bids must be submitted through e-GP system i.e. www.bolpatra.gov.np/egp on or before 12.00 Noon on 2022/03/04 and sealed quotation on 2022/2/17 respectively. Bids and sealed quotation received after this deadline will be rejected.
- 4. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12.30 PM onwards on 2022/03/04 for the bids and 2022/2/17 at 15.00 PM for the sealed quotation at the office of REDD Implementation Centre, Babarmahal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by the bid security which shall be valid for 30 days beyond the validity period of the bid. Bid security for sealed quotation must be valid for 75 days after bid opening date. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 1201200-001-002-524 Office Code: 329013503 at Nepal Rastra Bank and submit the receipt of the deposited amount of cash along with the Bid.
- 5. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date for submission and opening. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 6. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
