The REDD Implementation Centre has received financing from the World Bank and intends to apply parts of the proceed towards payments for four separate bids: 1) Procurement of Motorcycle to strengthen ER program districts Package-1 (Ref No. NP-REDD-271565-GO-RFB); 2) Procurement of Scooters to strengthen ER program districts Package-2 (Ref No. NP-REDD-271566-GO-RFB); 3) Procurement of Laptop, Desktop computer and printer to support collecting, analyzing and operation of National forest data management in ER program districts Package-1 (Ref No. NP-REDD-271556-GO-RFB); and 4) Procurement of digital screen, projector etc. to support collecting, analyzing and operation of national forest data management in ER program districts Package-2 (Ref No. NP-REDD-271562-GO-RFB)

3. Bids must be submitted through e-GP system i.e. [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12.00 Noon on 2022/04/08. Bids received after this deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13.00 PM onwards on 2022/04/08 at the office of REDD Implementation Centre, Babarmahal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by the bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 1201200-001-002-524 Office Code: 329013503 at Nepal Rastra Bank and submit the receipt of the deposited amount of cash along with the Bid.
5. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date for submission and opening. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
6. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
